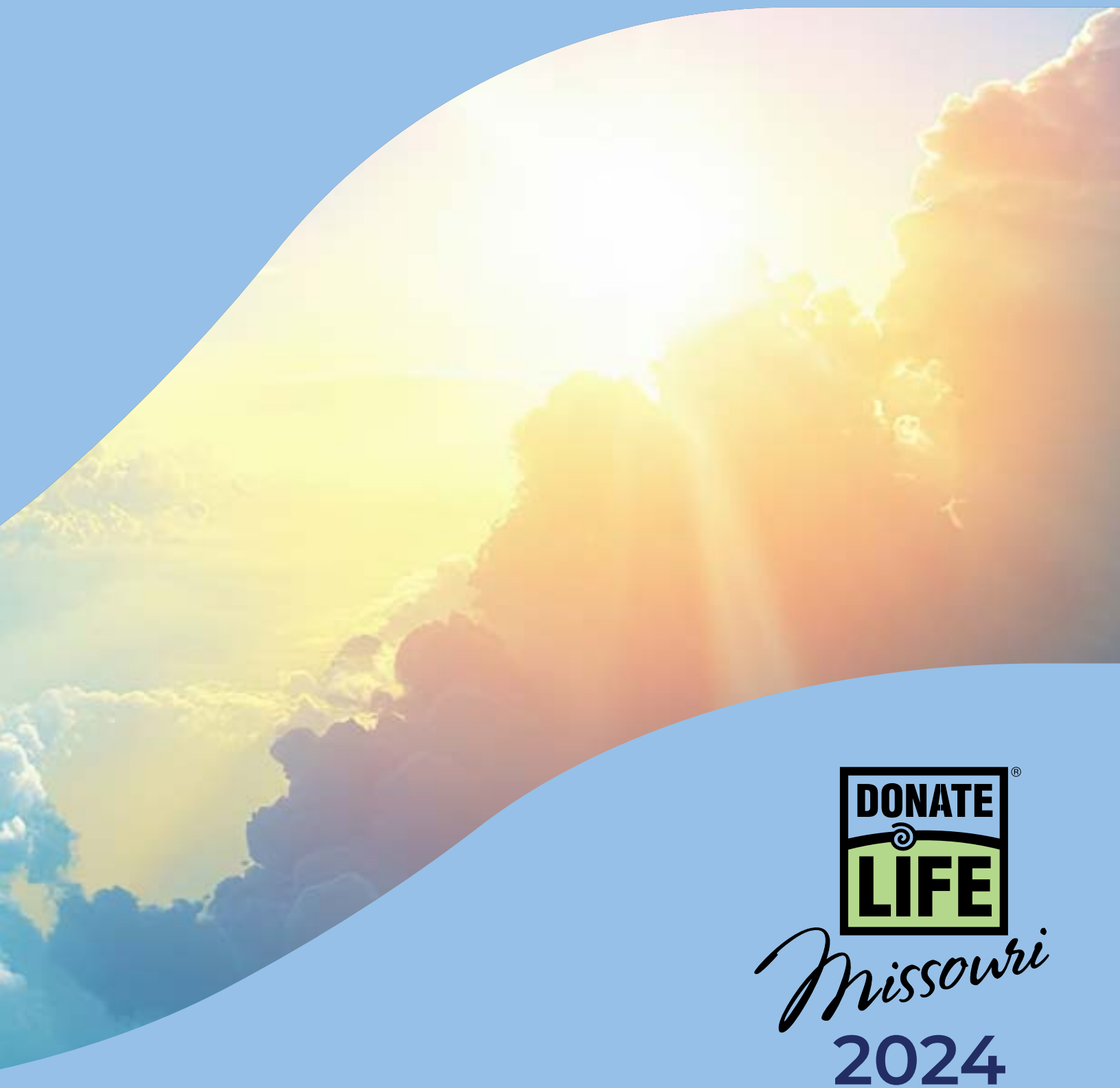

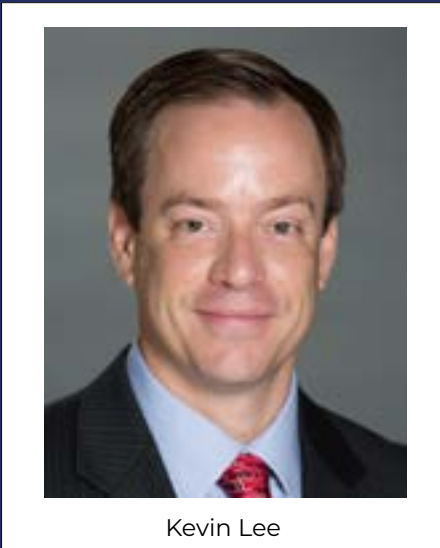

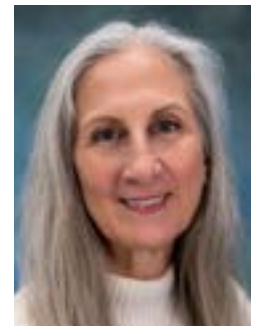

The committee is dedicated to this service through collaboration with partners across the state.

The ninth annual Donor Family Recognition program was held on April 16, 2024, in Jefferson City, MO. The Department of Health and Senior Services (DHSS) Organ and Tissue Donor Program and its partners, listed in the sidebar, honored the legacy of 134 organ, eye and tissue donors from across Missouri.

Donor families had the opportunity to visit Midwest Transplant Network, Mid-America Transplant, Saving Sight and Gift of Life located in the Capitol's third-floor rotunda. While at the Capitol, families enjoyed interacting with other families, visiting the museum and participating in one of the guided tours.

The Donor Family Recognition program took place at the First Baptist Church of Jefferson City. Families enjoyed painting mini canvases, making bracelets, and sharing experiences.

Many families braved the rainy weather to visit the Donor Paver Stone that honors Missouri organ, eye, and tissue donors located on Adrien's Island. Flower seeds donated from Baker Creek Heirloom and plants from the Missouri Department of Conservation were given to families to plant in honor of their loved ones. Natural Grocers of Jefferson City provided healthy snacks for families to enjoy, the organ and tissue procurement organizations provided a reception, and River City Florist generously provided flowers for the event. Families were provided a picture of their loved one in a photo mat with the words "Lived Life, Gave Life" to place on the dedication wall. DHSS Director Paula F. Nickelson presented a certificate and tribute coin to each donor family during the ceremony. Program speakers shared powerful stories of how donation or transplantation impacted their lives. Families

were given the opportunity to share stories of their loved ones during the event. Many powerful and emotional stories were shared.

The Donor Family Recognition is a memorable event that brings together families with a shared experience many do not understand. It is a time to reflect on their loved ones and the gift of life they provided to, in many cases, a total stranger. Families and those who could not attend were provided with a private link to a video of the ceremony.

Planning is underway for the 2025 event to be held on April 16, 2025. The Organ and Tissue Donor Program looks forward to working with partners and sponsors on this ever-growing, and humbling event.

A New View on Life:

Matt's Cornea Transplant Journey *by Jonah Durbin*

For Matt, a cornea transplant meant the difference between fading vision and a world brought back into focus. Matt's journey began unexpectedly after a seemingly minor ear infection ruptured as he slept. His eye touched the pillowcase where discharge from his ruptured eardrum lay and got under his contact which led to a rare fungal infection, causing severe vision impairment.

After initial treatment from his primary ophthalmologist, Matt was referred to Dr. Kenneth Goins at the University of Kansas Health System. "I learned about Saving Sight and a little about what could happen, and we talked about possibly looking for a donor," Matt said. Tests revealed the fungal infection in his eye was progressing rapidly, and Dr. Goins informed him he'd need a cornea transplant to preserve any hope of sight. "They were concerned I could lose 100% of my eyesight, and I needed a transplant ASAP," Matt recalled. Despite the challenges, he stayed focused on the possibility of regaining his sight.

Matt's experience with transplants started years before his cornea surgery when he received a life-saving kidney transplant from a living donor. That experience helped shape his understanding of the power of eye, organ and tissue donation, but it wasn't until he faced potential blindness that he fully appreciated how vital even the smallest parts of the body can be. "I didn't know how much a single tissue could impact someone's life until I was faced with losing my sight," he said. "It's incredible that two people have now given me this chance to live fully." For Matt, the cornea transplant stands as a reminder of the selflessness of donors and the profound difference their gifts make.

Gratitude fills Matt's heart as he speaks of the donor who made this possible. "I am forever grateful. Someone selflessly gave me the gift of sight, and it's overwhelming. What did I do to deserve such love and compassion?" he said. The impact of his donor's gift goes beyond Matt's renewed vision—it's a testament to human kindness and the power of eye, organ and tissue donation.

To those unfamiliar with the impact of donation, Matt has a simple message: "You might be able to save someone's life or change their world just by checking that box on your license. It's a chance to help someone in a way that goes far beyond what we can understand."

As he continues to recover and adjust to his new vision, Matt hopes to honor his donor's legacy by sharing his story and encouraging others to become registered donors. "I cherish every moment now," he said. "This gift has truly opened my eyes."

Missourians are generous people. Many contribute to the Organ Donor Program Fund while visiting their local license office. At the local office, they can contribute a dollar or more at the time of their transaction or when renewing their license plate. They also can order a “Be A Donor” license plate. For FY24, Missourians donated over \$350,000 through their local offices.

Since January 2023, the state treasurer has invested funds not required for immediate disbursement. Investing contributions that the generous people of this state voluntarily provide embodies responsible planning and management and encapsulates the

Department of Health and Senior Services strategic value of integrity. The investment earned \$21,820.74 in FY24.

All financial gifts to the Organ Donor Program Fund support the Donate Life Missouri Registry, the annual Donor Family Recognition Program, education efforts and the Organ and Tissue Donor Program. Donate Life Missouri Registry

During the winter/spring of 2024, a complete review of the Department of Revenue (DOR) driver's license and the Registry system processes was completed. This action was crucial to the Missouri Department of Health and Senior Services (DHSS) commitment to Registry accuracy and reliability and, as part of the Department's strategic priority, invest in innovation to make infrastructure modern. The review confirmed that processes work as intended and that the data is secure.

Design changes were made with the user in mind, making it easier for people to add, change, print or delete their Donate Life Missouri Registry record. Improvements also featured pop-ups that guide the public in simple and easy-to-understand language and an electronic signature block for the online removal process for consistent legal documentation.

The DHSS is working with the Office of Administration to establish a single-feasible source contract with the current Registry vendor to ensure steady and reliable service for our users. The contract is expected to be awarded in FY25.

We are grateful, humbled and inspired by the over 4,400,000 Missourians who have chosen to be registered donors, providing hope to those waiting by being potential donors who can heal or save lives in the future.

My Transplant Ready Workbook - 2nd Edition

DHSS' Organ and Tissue Donor Program partnered with the Missouri Kidney Program on the second edition of the My Transplant Ready Workbook. This workbook includes caregiver tips, living donation information, processes and steps along the way, tips, expanded resources and end-of-life documentation. Designed to be a comprehensive guide for patients and their caregivers navigating the complex kidney transplant journey, the workbook serves as a valuable resource for organizing crucial information, contacts and personal reflections. The workbook is available in English and Spanish languages at <https://mokp.org/education/patient-education/>.

Eighty-five percent of people waiting for an organ transplant in Missouri are waiting for a kidney. The workbook guides dialysis patients and others who want and are eligible for a kidney transplant through the complex process using clear language and graphics. DHSS and the Missouri Kidney Program aim to improve access to services for dialysis patients seeking a kidney transplant, another DHSS strategic priority.

Celebrated 55 Years!

Missouri has a long history of supporting organ, eye and tissue donation. The first Uniform Anatomical Gift Act drafted by the National Conference of Commissioners on Uniform State Laws; established a legal document of gift for all 50 states, identified who could donate a deceased person's organs and enabled anyone over 18 to legally donate his or her organs upon death. Missouri passed its version of the act in 1969.

Other milestones during these past 55 years include several revisions to the anatomical gift act, Missouri's registry system going from a physical card system with multiple levels of security measures to a highly sophisticated electronic system where the public can amend or remove their decision 24/7.

The Program has expanded to not only provide education and awareness, but to host an annual statewide Donor Family Recognition Program.

There are too many milestones to list here, however, we would be remiss if we didn't acknowledge that all efforts in Missouri are collaborative in nature. Key partners that make life-healing and life-saving

Learn Life Savers

The Organ and Tissue Donor Program is partnering with the Gift of Life, reaching out to public school districts across the state. School boards are being asked to watch a presentation about the program and determine if they will implement the online program within their district's high school(s). This free online program educates students about being asked if they want to be a donor at their local license office. The program encourages students to talk to a loved one about donations and any decisions they have made. The program includes an online teacher lesson plan, additional resources and short videos. No student information is collected as part of the online course.

Community Outreach

The Organ and Tissue Donor Program and its partners participated in the 2024 Missouri State Fair with a booth in the Mathewson Exhibition Center to hand out educational material. Partners included Midwest Transplant Network, Gift of Life, Missouri Kidney Program, Missouri General Federation of Women's Clubs, and Mid-America Transplant. There were 2,184 public interactions, 384 more than the 2023 Missouri State Fair. During these interactions, staff and partner volunteers met 42 transplant recipients, four living donors, 38 donor families and eight individuals waiting for a transplant.

The program presented information about the importance of organ, eye and tissue donation across the State of Missouri. In 2024, it reached more than 1,600 Missourians through health fairs and places of worship that requested information and presentations. The program continues to expand outreach and education efforts and build community relationships.

The staff is embarking on a new partnership with

the Missouri General Federation of Women's Clubs, which officially kicks off in FY25. This partnership will result in education efforts through newsletters, social media posts, material for community outreach, etc. DHSS looks forward to this new partnership and the opportunity it brings to educate Missourians and to gain life-long advocates for organ, eye and tissue donation.

Lastly, the program has re-established its partnership with the Missouri Broadcaster's Association. A digital and radio campaign will be implemented in FY25.

We thank our hunters and anglers for their support and for registering as organ, eye, and tissue donors. We look forward to our continued collaboration to help heal and save lives.

Missouri Kidney Program *by Lisa Parnell, Director*

The Missouri Kidney Program (MoKP) is a state funded organization that provides financial assistance for eligible Missourians who suffer from End-Stage-Renal-Disease or have received a kidney transplant.

The program additionally supports education and research. The program also partners with dialysis and transplant centers to assist in reducing the burden of the national kidney wait list.

Transplant Assistance

MoKP provides reimbursements for non-medical related expenses for kidney transplant recipients and/or a living donor. This can include lost wages due to time off work for surgery or travel expenses. There are many hurdles to obtaining a transplant and these funds help alleviate some of those barriers.

MoKP also fosters relationships with the transplant centers and dialysis clinics in the state, while exploring other opportunities to support the chronic kidney disease community. My Transplant-Ready Workbook – Second Edition

In the spring of this year, the Department of Health and Senior Services collaborated with MoKP and Health Literacy Media to complete the second edition of the “My Transplant-Ready Workbook”, which was published in English and Spanish languages were distributed to every dialysis clinic and transplant center in the State of Missouri, for their patients who are ready to pursue transplant. Gift of Life

Saving One Life at a Time *by Kim Harbur*

For 26 years Gift of Life located in Kansas City has saved one life at a time. This is accomplished with two programs: Life Savers and Transplant Mentors.

Life Savers

“Do you want to be a donor?” is asked at the DMV when applying for a driver’s license. The Life Savers high school education program educates students about this question so they can make an informed decision. They are also encouraged to share their decision with a loved one...because the conversation matters. This program is offered in person to high school classrooms within the Kansas City and St. Louis metropolitan areas. All districts across the state of Missouri are offered an online version of Life Savers. This free resource (learnlifesavers.com) can be accessed by any teacher in the state.

For the 2023-2024 school year, a total of 662 high school classroom presentations were completed in Kansas City and St. Louis by Gift of Life. We reached 15,008 high school students in the classroom and they shared their decision about donation with 26,570 individuals. The online program is being used in school districts across the state, but we continue to present to school boards in Missouri about learnlifesavers.com and encourage additional school districts to implement this program as part of their curriculum.

Gift of Life has expanded educational outreach to adults as well.

Transplant Mentors

A Transplant Mentor is a connection to insight, education, support and encouragement directly from someone who has traveled on a similar journey. You can never have enough support. Mentees regularly tell us they have had a better experience because they were able to connect with someone who had been through the transplant process themselves. Transplant Mentors is a free resource for anyone who is considering a transplant or living donation, received a transplant, or is a care partner. Talking to someone who has had a similar experience can instill confidence, calm nerves and provide hope to see positive outcomes. Gift of Life has assisted over 1,000 families on the transplant journey with our Transplant Mentors program.

Gift of Life empowers high school students, supports transplant patients, living donors and care givers and helps transform loss into hope.

Each year, the Donate Life America (DLA) recognizes the dedication of DMV staff and offices through regional and national awards presented at American Association of Motor Vehicles Administrators (AAMVA) conferences across the country. This year, I had the honor of nominating Sanela Hall, Manager of the South Kingshighway Agent Office, for the Lifesaver Award. This award acknowledges a DMV or DMV staff member who demonstrates exceptional commitment to saving lives through their support of the donate life mission. Sanela truly embodies this commitment.

Sanela has gone above and beyond by attending Lunch & Learn sessions at Mid-America Transplant's main office, where she learned more about our processes and met transplant recipients. She has also organized similar learning sessions for her staff at the South Kingshighway License Office. Additionally, Sanela and her team distribute Donate

Life informational brochures and display signage throughout the office, ensuring that customers have easy access to this important information while waiting in line.

When asked about the importance of the mission, Sanela shared, "Before, I would ask the two-part registry question because it was part of my job. But after meeting recipients and seeing a close friend benefit from the gift of life, I no longer just ask the question because it's my job. I ask because I've seen firsthand how one simple 'yes' can save and heal lives."

I am proud to share, in June, DLA announced Sanela not only won the regional award but also the national award. In October, Sanela and I traveled to Fargo, ND, where she accepted this prestigious award, and I had the privilege of representing the DLA by presenting at the awards luncheon and hosting an informational awareness table.

Transforming Lives Through Community Engagement

Saying “yes” to donation starts in the community, ensuring that Missouri residents are educated and informed when our partners at license offices ask, “Do you want to be a registered organ, eye and tissue donor?” Over the past year, Midwest Transplant Network (MTN) participated in more than 95 community events, totaling nearly 700 volunteer hours dedicated to sharing awareness and encouraging people in Missouri to give hope and share life through donation.

Strengthening Communities Through Education

One of MTN’s roles involves educating the public about the importance of organ, eye and tissue donation. This work extends to valued partnerships with local Departments of Motor Vehicles (DMV) when meeting people at a key decision-making moment - registering as organ donors. MTN’s team engages in office visits, provides resource materials, and offers training sessions to DMV staff. Through direct community engagement, MTN is increasing donor registrations and fostering a culture of giving.

Partnerships Lead to Impact

MTN has established meaningful partnerships with diverse organizations to increase outreach efforts. Collaborations with St. James United Methodist Church, The Bridge 90.9 FM and Telemundo Kansas City have been pivotal in reaching diverse communities. For instance, through St. James United Methodist Church, MTN connects with faith-based communities to address myths and offer education that builds trust and empathy. Telemundo Kansas City serves as a vital link to Spanish-speaking communities, ensuring that no one is left out of the conversation about donation and transplantation. Each year on National Donor Day, which is also Valentine’s Day, MTN and The Bridge 90.9 have personal conversations with donor hero families, transplant recipients, living donors and many who represent the organ, eye

and tissue donation community. They share their stories in their voices and inspire listeners to become registered donors.

Engaging Events and Celebrations

MTN’s presence at community events underscores its commitment to meeting people where they are to listen and have conversations. At the Kansas City Juneteenth Heritage Festival, MTN hosted an interactive booth to educate about the donation process and the impact on recipients and their families; attending the Kansas City Pride Festival, through a partnership with the National Marrow Donor Program (NMDP), was an opportunity to showcase the inclusive spirit of MTN’s work. By celebrating diversity and inclusion, MTN reaches people across cultures and communities.

MTN regularly attends community health fairs to share information and to encourage a better understanding of how everyone can contribute to the mission of saving lives.

Giving Time and Talent

MTN’s remarkable team of Ambassador volunteers exemplify the spirit of giving. Over the past year, the MTN Ambassador team collectively dedicated more than 700 hours of their time from staffing information booths to speaking engagements to office support and educational workshops. This incredible group of donor family members, recipients and living donors share their passion and dedication and inspire people to join the mission, creating a ripple effect of awareness and action.

Saving Sight

Effects of Eye Bank Donor Age Expansion on Corneal Endothelial Cell Density and Surgeon Tissue Acceptance *by Jonah Durbin*

In recent years, advancements in medical research have pushed the boundaries of what was once considered feasible in the field of ophthalmology. One such study observed the effect of the expansion of eye bank donor age on corneal endothelial cell density and surgeon acceptance rate of those tissues. Donor characteristics, endothelial cell density, and acceptance of tissues for use in surgery were compared between age groups in five-year intervals. The aim was clear: to assess how this expansion would influence the availability of corneal tissue for transplantation and challenge existing biases against older donors. Saving Sight was proud to partner with Dr. Roy Chuck and Ayobami Adebayo, among other researchers, to provide the corneal tissue used during this study.

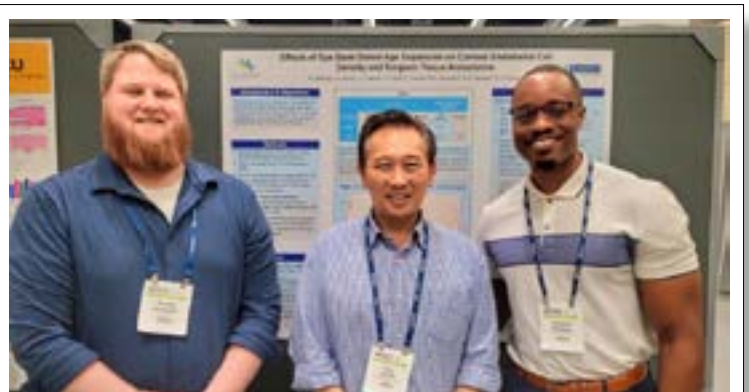
This single-site study featured 25,969 corneas from eye bank donors from 2018 – 2022 between the ages of 2 and 75. At the beginning of 2022, the donor age limit was increased to age 80, thus allowing donated tissue from older donors to be used in transplants. The age limit increase allowed an additional 411 more cornea donations, which led to 208 more transplants. The average endothelial cell density for the 71-75 age group was 2,349 cells/mm², compared to 2227 cells/mm² in donors aged 76-80. The difference of 122 cells/mm² doesn't seem like much, but the study saw that donors aged 71-75 had a 38% surgeon rejection rate, while those aged 76-80 had a 48% surgeon rejection rate.

There could be multiple reasons for the difference in surgeon rejection rate, but one could be age bias. Traditionally, corneas that come from older donors are looked at as not being viable while this study showed that corneas from older donors are still very viable for transplant. While there isn't a shortage of corneas for transplant in the U.S., there is a global shortage, resulting in patients in other countries waiting on the transplant list for months. "If we can expand the age pool to increase donations, that will increase transplants. And there is more room for growth in this area," said Ayobami Adebayo.

This study is important for the future of ophthalmology and eye banks due to a cornea shortage in other countries, and by increasing the

donor age limit, there will be more corneas available to use for transplant globally. Expanding the donor age limit and using those tissues in surgery can give the gift of sight to many more people who are in need across the globe. Potential age bias isn't the only factor in the difference in surgeon rejection rate, but it does show that more work needs to be done. "So, no matter what you do, there's still a bias against age and many things that we do in life, and that bias never disappears. So, you know, we can do one of two things. We can work to change everyone's mind just by talking to them. It's very difficult to do, and it's much easier for us to generate data, and that's what we're doing. That's the whole basis of research, you know, change thought by proving it with data," said Dr. Roy Chuck.

As researchers continue to navigate the complexities of eye, organ and tissue donation and transplantation, they remain committed to ensuring equitable access to sight-restoring treatments for all. By increasing the donor age limit there will be an increase in viable donor tissue for transplant, allowing those in underserved areas to receive the gift of sight. The journey to redefine how corneal donations are handled isn't solely about science; it's a moral duty with the chance to change lives by saving sight.

Educate, Inspire, Share

Missouri Department of Revenue *by Gina Wisch*

The Department of Revenue (DOR) Motor Vehicle and Driver License (MVDL) division and its approximately 175 contracted license offices continue to support the donor registry during driver license processing, allowing elections for registry participation and monetary donations of \$1 or more during in-person and online transactions. Motor vehicle services also provide program support through issuance of the “Be An Organ Donor” specialty plate and the option for vehicle titling and registration customers to make monetary donations at the time of application. The MVDL division deployed its modernized driver license and processing system statewide on November 12, 2024. The recent implementation is Phase 1 of a multi-phase project to modernize driver license and motor vehicle systems and processing. A part of this implementation included updates to the secure posting of application data for persons electing organ, eye and tissue donor registry participation.

“We want to thank our customers in advance for their patience and understanding during the transition. We are confident they will come to agree that it’s a small inconvenience compared to the benefits the modernized system will provide once it becomes fully operational,” said Missouri Department of Revenue Director Wayne



Wallingford, referencing the second and final phase of the modernization project, scheduled to roll out in July of 2026. “The second phase will be to the Department’s motor vehicle system, which will enable the two systems to ‘talk’ to each other. This final enhancement will make transactions much more seamless for our customers and our frontline staff.”

Phase II motor vehicle system work will begin in early 2025. The three-year project was made possible by 2021 legislation creating an auto dealer administrative fee for an Administrative Technology Fund dedicated to building a new integrated MVDL computer system. The new system will replace legacy systems within the Department that include more than 50 disparate driver license and motor vehicle software programs with limited ability to work together.

Some key improvements customers may now access are available through expanded eServices options such as online driver license renewal and duplicate requests for eligible credential holders. Online transactions will also present the required organ, eye and tissue donor registry participation election and optional donor symbol questions to requestors. 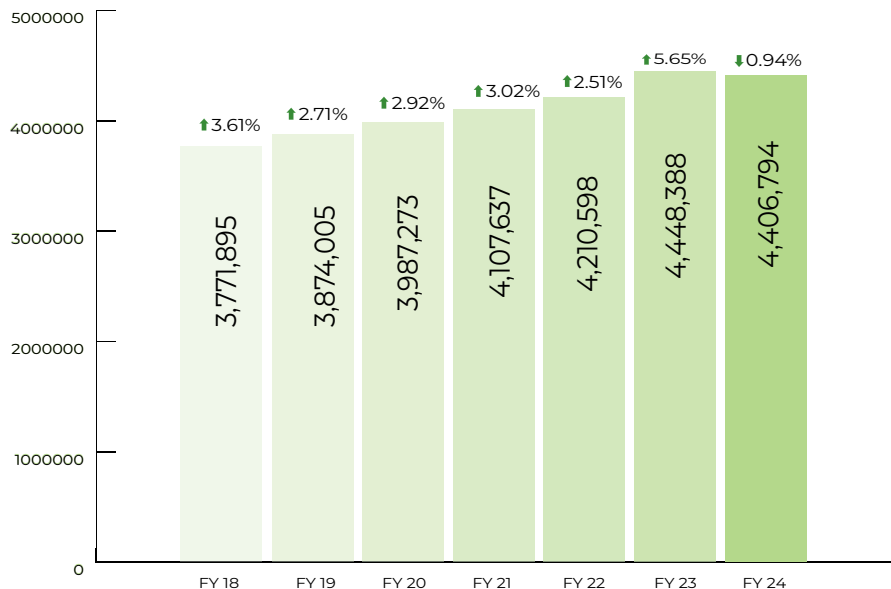

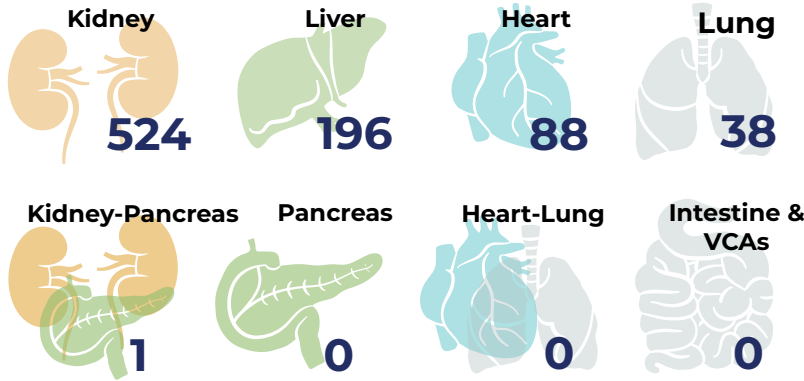
